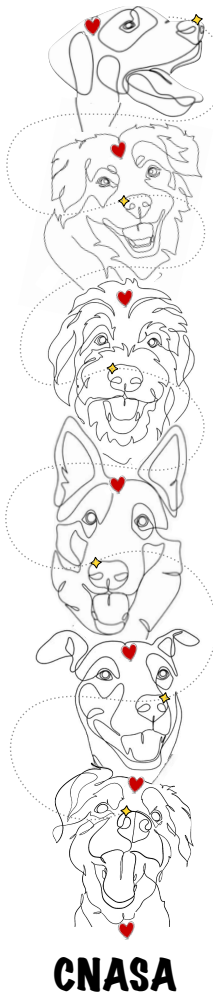

## Membership Registration

### 1. Introduction

### 2. Membership Eligibility

- Membership is open to all individuals interested in dog scent detection sports, regardless of experience level.
- Members must be at least 18 years old. Minors may register with parental / guardian consent.
- Members agree to uphold CNASA rules, ethical guidelines, and code of conduct during all events and activities.

### 3. Membership Fees

CNASA offers the following membership options:

- R300 annual fee (standard membership), renewable annually 1 Mar
- R180 for seniors and persons under the age of 18 yrs
- **Prorata fees:** Membership fees will be calculated on a prorata basis (from April of the current year until Feb of the next yr)
- Note that Organising Clubs may charge additional fees for participation in CNASA sanctioned Odour Recognition Tests (ORTs) and Trials.

### 4. Registration process

- An invoice will be sent within 7 working days.
- Registration is confirmed only after both the signed membership form and proof of payment (POP) have been received and verified by CNASA.
